1. Approval of Minutes. The Committee considered approval of the minutes of the meeting held July 22, 2025.

2. Chair Report

- Ashley Sisti delivered the Bay Area Wheelchair Tennis report. The BAWT group has maintained continuous weekend practices, with 8 people attending consistently. Several D players are signed up for the SacTown Classic next month. Don was happy to hear that D players were signing up and that BAWT may be getting an additional female wheelchair tennis player soon. - Kylie Hornbeck provided an update on the BORP clinic. There was a good turnout at the clinic run by Marty Anderson, Kylie Hornbeck and Christy Perez. One child even brought his 2 siblings. People seemed very interested in continuing tennis.
- Edgar Vidriales delivered an update on the SoCal Sectionals Tournament that will be held on September 9/6-9/7.

3. Staff Report

- Christy Perez reported on the Committee Operating Plan and that it has been submitted to NorCal for the next stage of review.
- Christy provided an update on the SacTown Classic Wheelchair Tournament, noting that there will be a tournament committee meeting for all volunteers and anyone who would like to be involved with the preparation of the tournament.
